Recognizing exemplary Volunteer & Community service by government employees in Colorado

These awards recognize government employees who have demonstrated sustained excellence in volunteer service leading to significant positive outcomes for their communities. These individuals must have demonstrated exceptional leadership skills in recruiting, inspiring, and coordinating groups of volunteers, devoted substantial time and effort to the advancement of volunteerism, or shown a deep commitment of voluntary action to address community needs outside their duties as government employees.

WHO CAN NOMINATE | Anyone can submit a nomination providing that they have first-hand knowledge of the nominee and the nominee's volunteer activities, and they have permission from the nominee to submit the nomination.

-  Self-nominations are not accepted
-  One nomination per nominee, multiple entries will result in the disqualification of all of your entries and all persons nominated by you.

ELIGIBILITY | Previous winners are not eligible.

Nominees must meet the following criteria:

-  A full time Federal, State, City or County government employee working in the State of Colorado.
-  For Federal employees, the nominees must work for a Federal Agency or Field Office located in the State of Colorado at the time the award is presented or working in a regional office is headquartered in the State of Colorado.

- ✚ At least 18 years of age
- ✚ Stationed in Colorado, if military.

SELECTION PROCESS | The Selection Committee is comprised of members of the Colorado Federal Executive Board (CFEB) Executive Committee and selected members from the CFEB Workforce Development Council.

- ✚ The selections will be based on an assessment of the scope, impact, and outcomes of the nominee's contributions
- ✚ The winners, nominators, supervisors & Agency/Field Office directors will be notified by April 17, 2019
- ✚ Selection Committee members and their respective staffs, volunteers, and committee members may not be nominated or submit a nomination.
- ✚ The selections will be based on an assessment of the scope and impact of the outcomes on the community as a result of the nominee's ongoing contributions to one or more volunteer projects that are not related to their duties as government employees.
- ✚ This award is for off-duty volunteer activities only.

INSTRUCTIONS |

- ✚ One nomination per nominee
- ✚ Nominations must be completed online by 5:00 pm (MST), 4/7/19
- ✚ The nomination must include a letter of support from the charitable organization validating the nominee's qualifications. The online form will ask you to upload the letter from your computer.
- ✚ We recommend that you read the following nomination information carefully and gather all the information you will need before starting the online nomination.
- ✚ Once you start the online nomination, you can't save it and come back later to finish.
