WHO CAN NOMINATE: Anyone can submit a nomination providing that they have first-hand knowledge of the nominee and the nominee's volunteer activities, and they have permission from the nominee to submit the nomination.

- One nomination per nominee, multiple entries will result in the disqualification of all your entries and all persons nominated by you.

ELIGIBILITY: Previous winners are not eligible.

Nominees must meet the following criteria:

A full time Federal, State, City or County government employee working in the State of Colorado.

- For Federal employees, the nominees must work for a Federal Agency or Field Office located in the State of Colorado at the time the award is presented or working in a regional office that is headquartered in the State of Colorado.
- ↓ At least 18 years of age.
- Stationed in Colorado if military or deployed as long as the unit they were assigned to is Headquartered in Colorado.

SELECTION PROCESS: The Selection Committee is comprised of members of the Colorado Federal Executive Board (CFEB) Executive Committee and selected members from the CFEB Workforce Development Council.

- The selections will be based on an assessment of the scope, impact, and outcomes of the nominee's contributions.
- The winners, nominators, supervisors & Agency/Field Office directors will be notified by April 28, 2023 or sooner.
- Selection Committee members and their respective staffs, volunteers, and committee members may not be nominated or submit a nomination.
- The selections will be based on an assessment of the scope and impact of the outcomes on the community because of the nominee's ongoing contributions to one or more volunteer projects that are not related to their duties as government employees.
- **4** This award is for off-duty volunteer activities only.
